<b>16</b>	BILLS: All bills/ documents will be raised in favor of The Punjab State Cooperative Milk Producers' Federation Limited, Verka Chandigarh Dairy, Industrial Area, Phase -1, Chandigarh
<b>17</b>	VALIDATIY OF CONTRACT: The contract shall remain valid for a period of one year. However, contract can be terminated earlier in case of any breach of contractual obligations and/ or malafide/ undesirable activity on the part of supplier within 15 days of the prior notice. The contract can be extended for a maximum period of one year with mutual consent of the purchaser and supplier at the same rate, terms & conditions. Any substandard material if found after installation done by any party will be blacklisted and the security will be forfeited.
<b>18</b>	The price quoted should be final and free from escalation and inclusive of commissioning charges. The quoted rates should be inclusive of all taxes, levies, loading/unloading, insurance, measurement expenses, freight, Octroi etc. and no price escalation due to any factor will be permitted at any stage.
<b>19</b>	INSPECTION: (a) The inspection of the material supplied by the successful tenderer shall be carried out by our authorized Inspection Officer/ Officers whose decision regarding quality and quantity will be final and binding. In case of rejection of the material, the supplier will give free replacement without any delay & objection within 15 days. Rejected goods, if not lifted within 15 days of intimation, the same will be disposed off by the consignee at the risk & cost of the supplier. No claim thereafter made by supplier will be entertained. (b) Inspection by the Verka Chandigarh Dairy or any officer on its behalf, shall not absolve the supplier of the responsibility to provide acceptable product nor shall it preclude subsequent rejection by the Verka Chandigarh Dairy during the use of the material or during the warranty period. (c) Consignee shall be at liberty to get the material tested from any outside laboratory. In case material is found not as per the laid down standard, testing charges shall be borne by the supplier. (d) Any substandard material if found after installation done by any party will be blacklisted and the security will be forfeited.
<b>20</b>	FORCE MAJEURE: For the purpose of this clause, "Force Majeure" means an event beyond the control of the supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not restricted to acts of the purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes. If a Force Majeure situation arises, the supplier shall promptly notify the purchaser in writing of such conditions and the cause thereof. Unless otherwise directed by the purchaser, in writing, the supplier shall continue to perform its obligations under the order as far as is reasonably practicable and shall seek all reasonable practical alternative means for performance not prevented by the Force Majeure event.
<b>21</b>	The bidder will be shortlisted for each job i.e. the job will be allocated to the lowest bidder for the specific job category.
<b>22</b>	The successful bidder has to submit documentary proof such as photographs, videos etc. along with the bills for verification purposes.
<b>23</b>	The successful bidder has to provide REKI services in the area of operation free of cost.
