Eliqibility Criteria

- 1. Consultant/Firm must have an experience of Industrial planning and development, renovation of existing buildings, construction of new buildings, interior works of offices, landscaping etc.
- 2. Consultant / Firm must have work experience of at least 7 years in "Providing Architectural Design and Engineering Consultancy Services". The Experience certificates issued by Government Organizations / Semi Government Organizations / State Government Public Works Department / Central Government / Public Sector Undertakings / Autonomous Bodies/ Municipal Bodies eligibility of the Public Limited Companies / Non-government organizations shall be accepted for assessing the eligibility of tender.
- 3. Consultant/Firm must have Average Annual Financial Turnover on "Providing Architectural Design and Engineering Consultancy Services" of Rs. 30 Lakhs. in the last three years ending 31.03.2022, duly certified by a Chartered Accountant, UDIN Certified balance sheet & Profit & Loss of last 3 years.
- 4. Consultant should have registered with concerned Apex Professional Governing Bodies i.e. Council of Architecture / Engineers.
- 5. Consultant/ Firm shall submit Affidavit concerning that they have never been blacklisted/ debarred by any Co-operative organization, Govt./Semi Govt. Department or State/Public sector undertaking etc.
- 6. Consultant/Firm must have valid Permanent Account Number & GST No.
- 7. Consultancy/Firm must have one of the Directors or Partners as Professional Consultant with valid registration from concerned Apex Professional Governing Bodies i.e. Council of Architecture/Engineers.
- 8. The Consultant/Firm shall require furnishing details of Skilled and Trained Manpower including Engineers, Architects and Technical Staff employed and details of various Software and Hardware available with Consultant.
- 9. Applications containing false and/or incomplete information are liable for rejection.
- 10. The selected Consultant shall be required to execute an agreement in the prescribed format.
- 11. Milkfed may terminate the agreement by issuing one month written notice to the Consultant/Firm, if deficiency in services is found.
- 12. If the Consultant fails to perform any of its obligations under this agreement, the Milkfed may terminate the services of the Consultant with a prior notice to wind up its affairs within a period of 30 days. However, prior to such termination, 30 days written notice shall be given to the consultant during which, consultant shall be asked to perform such obligation and make good the deficiencies.
- 13. If there are any delays on the part of Consultant or the Consultant does not complete the work at various stages as stipulated, the Consultant/Firm shall be penalized, accordingly, after sending a prior notice to make good the deficiencies. Maximum penalty levied shall be 5% of the total Consultancy fees.
- 14. The applicants must have registered office in Tricity (Chandigarh/ Panchkula & Mohali.
- 15. Consultant/Firm shall offer prompt Professional Services i.e. Architectural working drawings, Structural drawings, including design and all other drawings for various works, estimates / BOQ etc.
- 16. In case of dispute arising out of contract at Milkfed level/Unit level/Union level, the same shall be referred to the Registrar, Cooperative Societies, Punjab for dispute-resolution by him or by his nominee not below the rank of Deputy Registrar. The Decision of sole arbitrator of the R.C.S Punjab or his nominee shall be final and binding on both the parties. The provision of the Arbitration and conciliation Act 1996 or the Punjab Cooperative Societies Act, 1961 and as amended upto date which ever may be applicable shall apply to arbitration proceedings which shall be held at Chandigarh only.
- 17. Consultant/Firm shall has to register as one time nominal member of Milkfed by depositing nominal member fee of Rs.1000/- with Milkfed.
