RULES FOR BIDDING

The bidders will send their bids to a centralized email id i.e. gmmktg.milkfed@verka.coop as per the timeline mentioned above.

An acknowledge email will be sent to the bidder that his/her bid is in the requisite format and it is being accepted.

- 1) The bidder will be eligible to get the following information:

- Details of the license to be sold i.e. license value, expiration date, etc.
- The timeline for submission of bid, submission of password, and opening of bids.
- Address for communicating bid
- Format for bid submission (preferably in excel/word).
- Depiction/method of bid creation
- Rules of bidding process.

2) The bid mail should clearly mention the following things:

- The subject of the email should mention the word "RODTEP BID".
- The content or body of the email should mention the name, address, and contact details of the bidder.
- Attachments:
 - Copy of PAN card
 - Copy of GST
 - PASSWORD PROTECTED BID FILE

The bid mail should not mention the password for opening the PASSWORD PROTECTED BID FILE. In case the bidder mentions the password in the BID email then the bid of the bidder will be straight away rejected.

3) Another email mentioning the PASSWORD for bid may be sent by the bidder to the email address i.e. acc.milkfed@verka.coop. The PASSWORD email may contain the following information;

- Subject: RODTEP BID PASSWORD
- Name and address of the bidder
- Password of the BID

The bidder could send the PASSWORD BID as per the timeline mentioned above.

Any password email if received before the stipulated time period, will make the bid void.

4) The PASSWORD PROTECTED BID FILE will be opened in front of the purchase/sale committee and in case the password submitted by the bidder is found incorrect then the committee may call the bidder at the same time to get the correct password and in case the is unable to share the correct password then the bid will be considered void.

The committee will try to communicate the bidder by telephone and email and in case the bidder doesn't respond in the specific time frame i.e. 30 minutes, then the committee will reserve the right to decide the further course of action i.e. wait for more time, declare the bid of the respective bidder void/ extend the bid opening schedule/ any other decision as found suitable.
